1. The meeting was called to order at 5:30 p.m.
Present were Marc Miller, Trustee; Paula Crook, Clerk; Chris Carlson, Treasurer;
Township Residents.
2. After a review of the minutes of the July 12, 2021 meeting, Miller made a motion to approve the minutes. There was a second by Carlson. Miller, Crook and Carlson voted to approve the minutes. Motion carried 3-0.
3. **Township Auditing Board**
The beginning balance in the accounts is \$755,487.40. There were disbursements of \$365,683.75 leaving an ending balance of \$389,907.79. Carlson stated the Township had finished road projects in N. Point, St. Ives and Overbrook and many of those vendors were paid. All other expenses were normal. Miller made a motion to approve the treasurer's report. There was a second by Crook. Miller, Crook and Carlson voted to approve the report. Motion carried 3-0.
4. **Board of Highway Commissioner / Road Overseer Report**
 - A. The work in N. Point, St. Ives and Overbrook is complete. Carlson expects to get another 3-5 years on these roads.
 - B. The drainage is pending on Bellaire due to the contractor being a little behind. He will rock any ditches that were already at the outset of the project rocked.
 - C. With the projects complete from the first ½ of the year, if the budget is approved tonight the Township will begin looking at projects for 2022. Potentially this could include phase II of the Bellaire project and possibly the replacement/reconstruction of Kinkaid. In the Crestview mile west of 143rd, Meadows, Meadows II N. Point East could get new curb/gutter and crack sealing to get more life out of the asphalt streets.
 - D. The collapsed intersection at 143rd and 29th St N is being rebuilt at the request of residents last month.
 - E. Miller stated he spoke to Mike Keys who was not able to attend the meeting. Mike indicated he had been working in SSHID spraying weeds as recently as today.
5. **Old Business** – There is no old business
6. **New Business** – There is no new business
7. **Adjournment** – A motion was made by Miller with a second by Crook to adjourn the meeting at 5:37 p.m. Miller, Crook and Carlson approved the motion, 3-0.
