1. The meeting was called to order by Carlson at 5:30 p.m. Present were Paula Crook, Clerk; Chris Carlson, Treasurer; Township Residents; Township employee. Marc Miller is travelling for his deployment today and not available to attend remotely.
2. After a review of the minutes of the March 11, 2024 meeting, Carlson asked if there was a motion to approve the minutes. A motion was made by Crook with a second by Carlson to approve the minutes. Crook and Carlson voted to approve the minutes. Motion carried 2-0.
3. **Township Auditing Board**
The beginning balance in the accounts is \$599,090.09. There were disbursements of \$114,908.71 and receipts of \$65,590.21 leaving an ending balance of \$549,771.59. Tree work is being done in the Crestview mile. The Township purchased another mower. Road projects are beginning. Carlson asked for a motion to approve the treasurer's report. There was a motion by Crook with a second by Carlson. Crook and Carlson voted to approve the report. Motion carried 2-0.
4. **Board of Highway Commissioner / Road Overseer Report**
Carlson stated he is waiting on the schedule for work to be started on projects that have signed bids for Andale and APAC. There are projects scheduled for January through May. Carlson will begin looking at the second half projects in April and May.
5. **Old Business –**
St. Cloud – there is nothing new known
Villas II – there is no change in their quest for the roads to be made public
Sidewalk Project – on hold
6. **New Business –**
There is new decorum for the Minneha Township meetings in regard to the public discussions after the meetings. Carlson made a motion to limit each speaker to 3 minutes in order that the meeting can focus on necessary items and agendas. Crook made a second to the motion. Carlson and Crook voted to approve the motion. Motion carried, 2-0.
7. **Adjournment –** Carlson asked for a motion to adjourn. A motion was made by Crook with a second by Carlson to adjourn the meeting at 5:35 p.m. Crook and Carlson approved the motion, 2-0.
